

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NATIONAL CITY, CALIFORNIA, 1.) AWARDING A CONTRACT TO ORTIZ CORPORATION IN THE NOT TO EXCEED AMOUNT \$1,631,274.64 FOR THE P1 SEWER UPSIZE PROJECT - PHASE II NATIONAL CITY BLVD/30TH STREET, CIP NO. 20-01 2.) AUTHORIZING A 15% CONTINGENCY IN THE AMOUNT OF \$244,691 FOR ANY UNFORESEEN CHANGES; AND 3) AUTHORIZING THE MAYOR TO EXECUTE THE CONTRACT

WHEREAS, the existing 8-inch sewer between National City Blvd. and 30th Street is undersized and needs to be replaced; and

WHEREAS, on July 20, 2022, the bid solicitation was posted on PlanetBids, a free public electronic bidding system for contractors; and

WHEREAS, on August 18, 2022, five (5) bids were received by the 2:00 p.m. deadline; and

WHEREAS, upon a review of all documents submitted, Ortiz Corporation's, bid was deemed responsive and the lowest responsible bidder qualified to perform the work as described in the project specifications.


NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF NATIONAL CITY, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE, AND ORDER AS FOLLOWS:

Section 1: That the City Council hereby authorizes the Mayor to execute the contract with Ortiz Corporation for \$1,631,274.64 for P1 Sewer Upsize Project Phase II National City Blvd. /30th Street, CIP No. 20-0, attached to the Agenda Report as Exhibit 4.

Section 2: Authorizes a 15% contingency in the amount of \$244,691 for any unforeseen changes.

Section 3: That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.
