Adopt a Resolution Entitled, "Resolution of the City Council of the City of National City, California, Amending City Council Policy Nos. 101, 104, 106, 107, and 121."

ACTION: Motion by Councilmember Bush, seconded by Vice-Mayor Yamane to revise Policy 104 (C) to allow Zoom registration for public comment up to one-hour prior to the start of the City Council meeting.

ACTION: Motion by Councilmember Molina, seconded by Bush to approve the suggested changes to Policy 121 and for the City Attorney to add a sentence to allow retroactive approval for travel to conferences and training. In addition, to include a clause regarding appropriate use of travel funds for legislative reasons, per the legislative platform of the City, so long as the City Council has taken a position on that specific legislation, the travel would be allowed.

Amended Motion by Councilmember Bush, seconded by Councilmember Molina to revise language to Policy 121, Section B, paragraph four to read, "All consulting contracts shall be reviewed and approved by the City Council" and to remove the last sentence that reads, "For contracts below \$50,000, the City Manager has the discretion as to whether City Council approval is required."

The Sale of Alcohol is a Conditionally-Allowed Use in Minor Mixed-Use Corridor Zone and Would be Accessory to Food Sales in the Restaurant.
